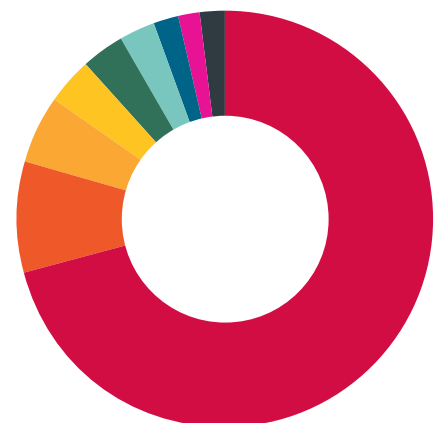
Our Funding Priorities

Keeping Mothers and Babies Together *Thanks to Sara Govero*

Seeing your child for the first time is supposed to be one of the happiest moments in a parent's life, but for some it can be one of the scariest. For many reasons, not all infants are born with the ability to breathe and thrive on their own.

In the past, a baby born in respiratory distress at Mercy Hospital Jefferson would be quickly transferred to a higher acuity hospital.

When Mercy Health Foundation Jefferson Board member Sara Govero heard that some babies must be transferred away from their mothers, she wanted to help find a solution.

Through her generous donation to Mercy Health Foundation, Sara helped the hospital purchase three Vapotherms. This specialized piece of equipment offers respiratory support for infants. Since the Childbirth Center began using the Vapotherms, 65% of infants with respiratory distress symptoms have stayed at Mercy Jefferson with their mothers. Sara also recently contributed to the purchase of two portable pulse oximeters, which are small devices that monitor the amount of oxygen in a newborn's blood. These devices help caregivers better monitor respiratory progress, so that the newborn is more likely to be able to stay with Mom.

"It's not just about investing in the care of an individual, but in the care of our community," Sara said. "It's important to enhance the technology at our local hospital so our community can receive the best and most up-to-date care close to home."

Mercy Hospital Jefferson has seen a 25% increase in births since 2015. Sara's passion is helping local babies thrive. Her support and yours help us continue to bring advancements to the only birthing center in Jefferson County.

Lighting the Way for Mental Health

Mercy Health Foundation's Lantern Gala, held on May 4, 2019 at River City Casino and Hotel, raised more than \$140,000 to support adolescents and adults seeking mental health services at Mercy Hospital Jefferson's new intensive outpatient program.

While 350 guests enjoyed fine dining and a fabulous silent and live auction, live music was performed by SMASH Band and a guest artist created a one-of-a-kind painting which is now on sight at the Outpatient Behavioral Health Center.

The event's co-chairs, State Rep. Elaine Gannon and former Mercy Health Foundation Board Chair Bill McKenna, contributed their time and talent to help coordinate a fun and successful gala. "The Foundation's gala is one of our community's premiere events. Attending this celebration is a fantastic way for people to invest in the health of their friends and neighbors," Bill said.

Mercy Jefferson's new intensive outpatient program helps adolescents and adults in our community through personalized treatment programs.

Since 2015, the Gala has raised more than \$590,000 to support patients at Mercy Hospital Jefferson. Mercy Health Foundation's next gala will be held in 2021.

On The Road Again

Sharon Head survived a stroke in 1995 and then again in 2018. She's also endured several trips to the hospital for ongoing and severe pain from Crohn's disease. Sharon needed rehabilitation therapy to recover from her health difficulties.

"When I came to the Acute Rehab Unit (ARU) at Mercy Hospital Jefferson, I was so weak. The staff took such good care of me that I quickly gained back my strength," Sharon said. "The care was so different from other hospitals. Everyone from the doctors, to the nurses, to the staff were so kind to me. Everything they do is for the patient."

Sharon was fortunate enough to benefit not only from Mercy's compassionate caregivers, but also from many specialized pieces of rehabilitation equipment.

One of those specific pieces included a car simulator that was purchased in May 2019 with your generous gifts to Mercy Health Foundation. The simulator helps patients learn to transfer from a wheelchair to a vehicle in a safe environment. As Sharon began to gain her strength back, she used the car simulator to prepare herself to drive again.

Many patients in the ARU at Mercy Hospital Jefferson are still capable of driving, but the closest pre-driving program for those residing in Jefferson County is at Mercy Hospital St. Louis.

"We are very thankful to Mercy Health Foundation donors who made the car simulator a possibility. It is an important addition to our unit as patients make progress toward returning to the community," said Eric Baldonado, Director of Therapy Services at Mercy Hospital Jefferson.

The car simulator will soon receive several accessories also funded through gifts to Mercy Health Foundation. These accessories will allow patients to experience a driving simulation and will provide a reaction time tester to help measure a patient's progress and readiness.

The car simulator is especially helpful for those with a neurological diagnosis such as a stroke, Parkinson's Disease or traumatic brain injury. More than 200 patients receive therapy in the ARU each year.

Sharon, and many others like her, will now experience an enhanced level of care in Jefferson County and be able to better recover from their illnesses while staying close to home.
