About Mercy

A young Irish woman named Catherine McAuley received an unexpected inheritance from a couple she lived with and for whom she provided care. She used those funds to open the first House of Mercy, serving impoverished women and children in Dublin, Ireland.

Catherine founded the Sisters of Mercy in 1831, a new kind of religious community – one that lived outside cloistered walls. They devoted their lives to ministering to the sick, poor and uneducated. They set up 14 Houses of Mercy across Ireland and England in the span of 15 years. By 1853, the Sisters were working on several continents.

The Sisters of Mercy arrived in St. Louis in 1856 to help the poor and sick. In 1976, the former St. Francis Hospital in Washington became St. John's Mercy and later renamed Mercy Hospital Washington. The mission of the Sisters continues today in our community.

Our Commitment

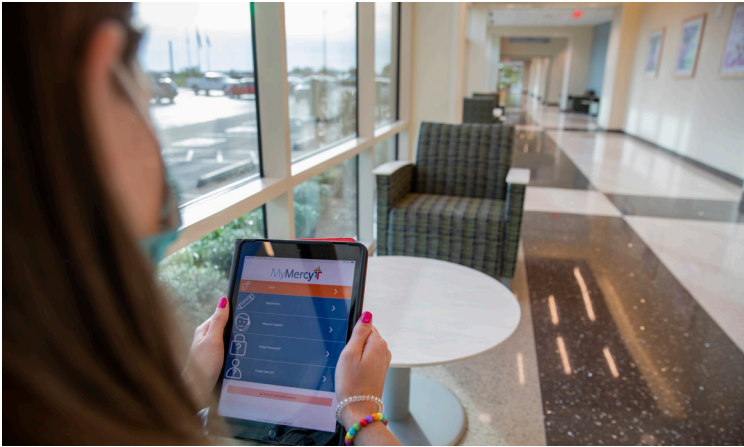

Area of Greatest Need
