Accessing the website means you agree to these terms.

These Website Terms ("Terms") are made up of the Terms of Use, Intellectual Property Policy, Privacy Policy, and Electronic Communications Policy and are a legal agreement between you, the end-user of the Website, and Mercy, acting on behalf of its subsidiaries, affiliates, and licensors, ("Mercy"). We respect your privacy. This Privacy Policy explains how we collect and use your personal information on this Website. Please read it carefully.

This policy describes how Mercy collects and uses personal information through this Website. Personal information does not include protected health information (PHI). The Notice of Privacy Practices (/about/legal-notices/privacy) describes how we use and disclose your PHI. What Information Do We Collect?

Mercy automatically collects certain information from your device when you visit the Website. This information includes information about:

- Your device, such as which operating system or browser your device uses
- The date and time you visited the Website
- Where your device is located
- Which pages on our website you have visited
- Which page(s) on the Internet you came from
- The times and dates you visit the Website
